


Order Delegated MI from OpenClose's LenderAssist



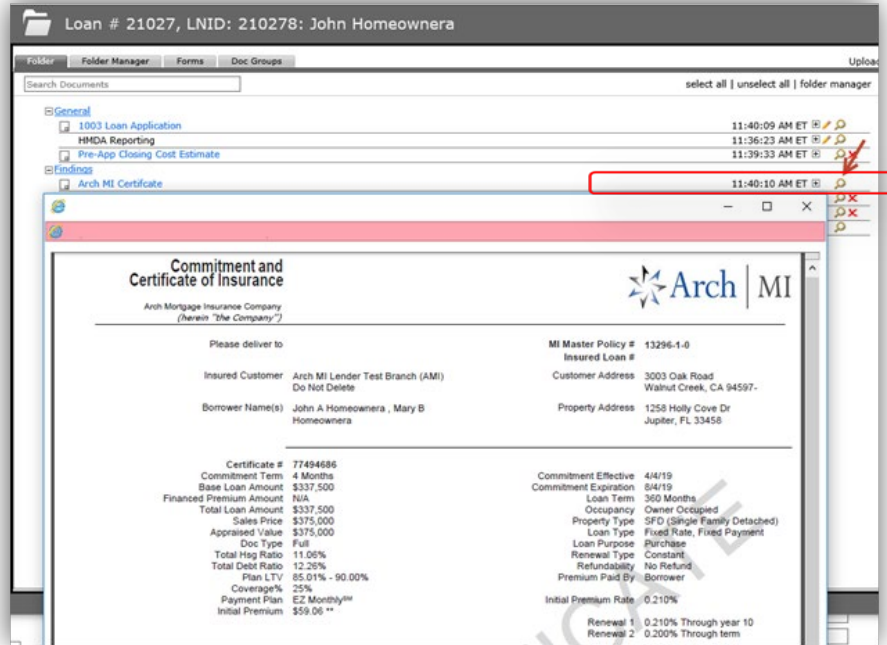
