Single Premium

A one-time premium paid at loan closing.

BPMI (Borrower-Paid Mortage Insurance)

Borrower-paid mortgage insurance premiums are collected by the servicer from the borrowers.

Loan Program Pricing Categories

Fixed-Rate-Mortgages

Feature level interest rates for at least the first 5 years.

Non-Fixed Rate or Adjustable-Rate Mortgages (ARMs)

Feature interest rates that have the potential to change within a period less than 5 years. Negative amortization mortgages, including option payment mortgages, are ineligible for coverage.

Loan Term Pricing Categories

> 25-Year Mortgages

Includes loans that fully amortize over periods greater than 25 years and not more than 40 years.

≤ 25-Year Mortgages

Loans in this category must fully amortize over a maximum of 25 years.

No Refund

Under non-refundable premium plans, refunds may only be available if coverage is canceled or terminated under the Federal Homeowners Protection Act of 1998 and such refunds will be processed in accordance with the Act. For all other cancellations or terminations, there is no refund.
