

# **Arch MI Privacy Notice**

#### Last Revised: December 6, 2023

At Arch MI¹, we know that personal information is important to you, and we want you to know that we take your privacy seriously.

Please take the time to read this Notice. It explains what we do with personal information about you and what measures we take to protect your privacy.

In short, we collect various types of personal information when you visit our website, when you sign up to receive special email offers, promotions and industry information, when you (as a representative of a lender) apply for mortgage insurance, when you apply to us for a job, when you make a payment to us or when you submit a query via our website, email or over the phone. If you have a mortgage with a lender we insure, there are times when we may confirm information on your loan application or collect additional personal information directly from you.

If you are a representative of a lender, we encourage you to provide this Notice to your borrowers.

Arch MI may possess more personal information about you, but that is often by virtue of our having received the information in our role as a mortgage insurer. In those instances, we also encourage you to review your lender's privacy notice or policy.

With respect to personal information we collect about you, you may be entitled to certain rights, so we encourage you to read this Notice carefully and contact us if you have any questions.

# Who Are We?

We are Arch Mortgage Insurance Company and various affiliated entities, and our address is: Arch MI, 230 N. Elm St., Greensboro, NC 27401.

# What Is "Personal Information"?

When we use the term "personal information" (otherwise known as "personal data" or "personally identifiable information"), we mean nonpublic information that identifies, relates to, describes, is reasonably capable of being associated with or could reasonably be linked, directly or indirectly, with a particular consumer or household. It is a broad definition and may include pieces of information like your name, address, phone number or email address.

Certain pieces of information that are not personal information include publicly available information, de-identified information or aggregate information. By "aggregate information" or "de-identified information," we mean information that does not allow us to identify or contact a specific individual. For example, the number of users of our website is aggregate information, which does not reveal users' identities. We will not attempt to re-identify de-identified personal information.

### What Personal Information Does Arch MI Collect?

Whenever we collect personal information about you, we do so in accordance with the principles outlined in this Notice and applicable law. Note that while we may use terms like "lawful basis" from a particular law (i.e., the European Union's General Data Protection Regulation, or GDPR), it does not necessarily mean that the specific law applies to us. In addition, we strive to be as transparent as possible, at times even more than what is required by law.

If you choose not to provide us personal information or withdraw your consent to processing (where applicable), it may affect our ability to provide you the services you have requested or to process your employment application.

Does Arch MI Share Personal Information with Other Companies?

We will not intentionally share your personal information with unaffiliated entities except: (1) as described in this Notice or as disclosed at the time personal information is provided, or (2) with your consent.

Arch MI works with third parties that provide services to us and we may share personal information with them, including without limitation: mortgage insurance underwriting and related services, website hosting or information technology consulting services, recruitment services, marketing and promotion services, newsletters, data analysis, legal services, accounting services and other administrative, backup and security services.



We may also disclose personal information in order to: (1) comply with applicable laws; (2) respond to governmental inquiries or requests; (3) comply with valid legal processes; (4) protect the rights, privacy, safety or property of Arch MI, our parent company Arch Capital Group Ltd., website visitors or the public; (5) permit us to pursue available remedies or limit the damages that we may sustain; and (6) enforce our Terms and Conditions.

In the event there is a change in Arch MI's corporate structure, such as, but not limited to, merger, consolidation, sale, liquidation or transfer of substantial assets, Arch MI may, in its sole discretion, transfer, sell or assign information collected on and through this website, including, without limitation, personal information concerning visitors, to one or more affiliated or unaffiliated third parties.

We do not sell personal information nor do we intend to in the future.

#### If I Link to Another Site and Provide Information to That Site, How Will That Information Be Handled?

This website may contain links to other websites. The operators of other websites may collect information about you, including through cookies or other technologies. If you link to another site, you will leave this website and this Notice will not apply to your use of and activity on those other sites.

Links on the website to other websites are provided only as a convenience and the inclusion of such links does not imply endorsement of the linked site. We encourage you to read the legal notices posted on those sites, including their privacy policies. We shall have no responsibility or liability for your visitation to, and the data collection and use practices of, those other sites.

#### What Are My Rights?

You may have various rights with respect to the information we have about you, depending on your state of domicile, the particular information and the context in which it was obtained. These rights are defined under a variety of privacy laws and regulations, each of which may or may not be applicable to our relationship with you or certain information we have about you.

We may choose to offer these rights to you in the interest of transparency and as an enhanced service to our customers, even if we are not required to under applicable law.



#### Privacy Rights under GLBA and the Fair Credit Reporting Act

In general, to the extent we receive, obtain or generate information about you in connection with providing a financial service or product within the United States, your rights with respect to that information are generally governed by the Gramm-Leach-Bliley Act (GLBA). We may *receive* this kind of information in connection with mortgage insurance provided to lenders but typically you are not our consumer or customer as those terms are defined in the GLBA. Nonetheless, as required by GLBA, as a recipient of the information we protect that information to keep it confidential and secure, and we do not share or use this kind of information other than as necessary for providing the financial product or service. If you have questions about how information about you is collected and used in connection with a personal mortgage, please contact your lender.

In connection with providing financial services or products, we may also receive or obtain information about a borrower's creditworthiness subject to the Fair Credit Reporting Act. We need to handle and share this personal information to run our everyday business. We may use and share this information for the following purposes:

- <u>For our everyday business purposes</u> such as to process transactions, maintain accounts, respond to court orders and legal investigations, or report to credit bureaus.
- For our marketing purposes to offer our products or services.
- <u>For our affiliates' everyday business purposes</u> only information about your transactions and experiences with Arch MI.

You cannot limit the use or sharing of FCRA data for these lawful purposes. Federal law gives you the right to limit only:

- Sharing for affiliates' everyday business purposes information about your creditworthiness.
- Affiliates from using your information to market to you.
- Sharing for non-affiliates to market to you.

We do not share information for these purposes. Should we share information for these purposes in the future, we will notify you before doing so and you will have the right to opt out of that sharing.

# <u>Privacy Rights under certain states with expanded privacy laws (Including: California, Virginia, Colorado, Connecticut, Texas, Utah, Oregon and Montana)</u>

#### The California Consumer Privacy Act

For California residents, subject to certain conditions and limitations (particularly for personal information that is exempt under California law because it is covered by the federal Gramm-Leach-Bliley Act), you may have the following rights with respect to personal information about you:

<u>Right of Access</u> — You may be entitled to request that we disclose to you the personal information we have collected about you, the categories of sources from which the information was collected, the purposes of collecting the information, the categories of third parties we have shared the information with and the categories of personal information that have been shared with third parties for a business purpose. Data solely retained for data backup purposes is principally excluded.

<u>Right of Data Portability</u> — In some instances, you may have the right to receive the information about you in a portable and readily usable format. Before providing this information, we must be able to verify your identity. Data solely retained for data backup purposes is principally excluded.



Right to Have Personal Data Erased — Subject to certain conditions and limitations, you may be entitled to request that we delete your personal information. Before deleting information, we must be able to verify your identity. We will not delete personal information about you when the information is required to fulfill a legal obligation, is necessary to exercise or defend legal claims or where we are required or permitted by law to retain the information. For example, we cannot delete information about you while continuing to maintain the mortgage insurance policy relating to your loan. Data solely retained for data backup purposes is principally excluded.

<u>Right to Correction</u> — You may be entitled to request that we correct inaccurate personal information about you that we maintain in our business. We shall use commercially reasonable efforts to correct such inaccurate personal information.

<u>Right to Opt-out of Sale or Sharing of Personal Information</u> — An opt-out right is not provided since we do not sell personal information. Furthermore, we only share personal information as described above in the section titled "Does Arch MI Share Personal Information with Other Companies?" We do not share personal information for cross-contextual behavioral advertising.

#### State Privacy Laws of Virginia, Colorado, Connecticut, Texas, Utah, Oregon and Montana

For residents of these states, subject to certain conditions and limitations (particularly for personal information that is exempt under your state law because our company is covered by the federal Gramm-Leach-Bliley Act), you may have the following rights with respect to personal information about you:

<u>Right of Access</u> — You may be entitled to request that we disclose to you the personal information we have collected about you, the categories of sources from which the information was collected, the purposes of collecting the information, the categories of third parties we have shared the information with and the categories of personal information that have been shared with third parties for a business purpose. Data solely retained for data backup purposes is principally excluded.

<u>Right to Obtain a List of Third Parties to Which Personal Data Was Disclosed</u> — You may be entitled to obtain a list of specific third parties, other than natural persons, to which we have disclosed your personal data.

<u>Right of Data Portability</u> — In some instances, you may have the right to receive the information about you in a portable and readily usable format. Before providing this information, we must be able to verify your identity. Data solely retained for data backup purposes is principally excluded.

<u>Right to Have Personal Data Erased</u> — Subject to certain conditions and limitations, you may be entitled to request that we delete your personal information. Before deleting information, we must be able to verify your identity. We will not delete personal information about you when the information is required to fulfill a legal obligation, is necessary to exercise or defend legal claims or where we are required or permitted by law to retain the information. For example, we cannot delete information about you while continuing to maintain the mortgage insurance policy relating to your loan. Data solely retained for data backup purposes is principally excluded.

<u>Right to Correction</u> — You may be entitled to request that we correct inaccurate personal information about you that we maintain in our business. We shall use commercially reasonable efforts to correct such inaccurate personal information.

<u>Right to Opt-out of Sale and Targeted Advertising</u> — An opt-out right is not provided since we do not sell personal information, nor do we process personal data for targeted advertising.

<u>Right to Opt-out of Profiling of Data</u> — You may be entitled to limit the automated processing of personal data to evaluate, analyze or predict personal aspects concerning your economic situation, health, personal preferences, interests, reliability, behavior, location or movements, if such processing is in furtherance of decisions that produce legal or similarly significant effects. However, any such automated processing we may use would only be



pursuant to an exemption recognized by applicable state law, thus no opt-out right is provided.

<u>Opt-in for Sensitive Data</u> — Your consent is generally required to process your sensitive data. However, we only process such data under an exemption recognized by applicable state law, thus no opt-in right is provided.

<u>Appeal Rights</u> — You may be entitled to appeal any decision we have made on a request you have submitted regarding your rights.

Without prejudice to any other administrative or judicial remedy you might have, you may have the right to lodge a complaint with regulators where you live if you believe that we have infringed applicable privacy or data protection requirements when processing your personal information.

If you chose to exercise any of these rights, to the extent that they apply, state law prohibits us from discriminating against you on the basis of choosing to exercise your privacy rights. We may, however, charge a different rate or provide a different level of service to the extent permitted by law.

#### **How Do I Submit a Privacy Request?**

Requests to exercise your privacy rights as noted above, to the extent applicable, may be made by following the link (archgroup.com/privacy-request-form/) or calling 877-800-6249.

Before providing information you request in accordance with your rights, we must be able to verify your identity. In order to verify your identity, you will need to submit information about yourself, including, to the extent applicable, providing your account login credentials or other account information, answers to security questions, your name, government identification number, date of birth, contact information or other personal identifying information. To the extent your request relates to mortgage insurance or a mortgage loan, we will need information relating to the mortgage loan and subject property. We will match this information against information we have previously collected about you to verify your identity and your request. To the extent you maintain an account with us, we will require you to log in to that account as part of submitting your request. If we are unable to verify your identity as part of your request, we will not be able to satisfy your request. We are not obligated to collect additional information in order to enable you to verify your identity. For deletion requests, you will be required to submit a verifiable request for deletion and then to confirm separately that you want personal information about you deleted.

If you would like to appoint an authorized agent to make a request on your behalf, and that agent is not already authorized to access your account in your profile, please submit a notarized special power of attorney or a signed letter from an attorney representing you, identifying the agent and authorizing them to submit requests and receive information on your behalf. We may require you to verify your identity with us directly before we provide any requested information to your approved agent.

#### How Do I Appeal a Response Received to a Privacy Request?

Requests to exercise your right of appeal to a response received under the privacy rights as noted above may be made by following the link (archgroup.com/privacy-request-form/) or calling 877-800-6249.

#### **How Long Does Arch MI Retain My Personal Data?**

We retain your personal information only for as long as necessary in accordance with our document retention policy and in accordance with legal, regulatory, tax or accounting requirements, or for dealing with complaints, legal challenges or prospective litigation.



We consider the following criteria when determining how long a particular record will be retained, including any personal information contained in that record:

- How long the record is needed to provide you the products and services you request.
- How long the record is needed to support and enhance our operational processes.
- How long the record is needed to protect our rights and legal interests.
- How long the record must be retained to comply with applicable laws and regulations.
